

GDPR Privacy policy Elaine Macha Counselling

The Privacy Policy for Visitors applies to everyone who visits the website Elaine Macha Counselling.

1. Management: The website Elaine Macha Counselling is owned by Elaine Macha Counselling and is managed by wix.com. The contact details of Elaine Macha Counselling can be found on the aforementioned website.

2. Visitor data:

a. Some data resulting from one or more visits to Elaine Macha Counselling is stored permanently, but anonymously. The data will therefore never be traceable to a person or organization.

b. Wix.com ensures good security of the stored data and does this on behalf of and under the responsibility of Elaine Macha Counselling

3. Cookies

a. Elaine Macha Counselling uses functional cookies to optimize the functionality of certain pages of the website. Cookies are small text files that are placed on the visitor's computer by a page of the website. Such a cookie stores information such as certain preferences of the visitor. This allows Elaine Macha Counselling to serve the visitor even better on a subsequent visit, for example by checking which domain names the visitor has checked and saved. You do not have to enter the same information again and again. This makes the site much more user-friendly.

b. The visitor can decide for himself how to handle cookies. He or she can set his or her browser in such a way that it allows, does not allow or partially allows the use of functional cookies. In the latter case, you can set which websites are allowed to place functional cookies. It will then be prohibited on all other websites. This option is provided by the most common modern browsers.

c. Cookies can always be deleted from a computer, again via the browser.

d. Wix.com uses Analytics cookies that do not track the surfing behaviour of individuals but of large numbers of visitors - anonymized - are processed into graphs and patterns that help to improve and optimize websites.

4. Questions:

Visitors can contact Elaine Macha Counselling with their questions about this Privacy Policy, the contact details are listed on the website mentioned in Article 1 of this Privacy Policy.

5. Disclaimer:

Elaine Macha Counselling is entitled to change the content of the Privacy Policy without informing the visitor. Implementing the change on the website is sufficient for this.

6. Data provided by the visitor; Elaine Macha Counselling can use the data provided by the visitor for the following purposes:

a. Processing the enquiry.

b. Sending one or more emails related to the enquiry, such as, but not limited to, an email containing details of appointment times.

c. (Occasionally) bringing attention to an offer, etc., which Elaine Macha Counselling thinks can contribute to a more successful website for the customer.

d. Providing data to third parties: Data provided by the customer to Elaine Macha Counselling will never be passed on to third parties. There is one exception to this: When a court order has been issued to provide data.

7. Security:

The data that the visitor provides to Elaine Macha Counselling is stored in a secure environment.

8. Adjustment of visitor data:

The visitor has the option at any time to change, view or request deletion of the data provided. In such a case, Elaine Macha Counselling may ask the visitor to report the change in a manner prescribed by Elaine Macha Counselling and in some cases identification may be required.

9. Back up of visitor data:

Data obtained from enquiries via Elaine Macha Counselling, will be backed up on a secure hard drive, with password protection, on an annual basis.
